**INFLATABLE INDUSTRY VISIONARIES
PROMOTE SAFETY WITH \$20,000 AWARD**

*Ninja Jump, IIPG, and Fireman's Fund Insurance Company to Award Grant to
Orange County Fire & Rescue During IAAPA Attractions Expo*

ORLANDO, Fla. (November 17, 2008) – Ninja Jump, Inflatable Industry Purchasing Group (IIPG), and Fireman's Fund Insurance Company are partnering at IAAPA Attractions Expo 2008 to promote safety among convention attendees. These leaders in the Inflatable Play Structures segment of the amusement industry are awarding the Orange County Fire & Rescue Department a \$20,000 grant to purchase needed equipment.
